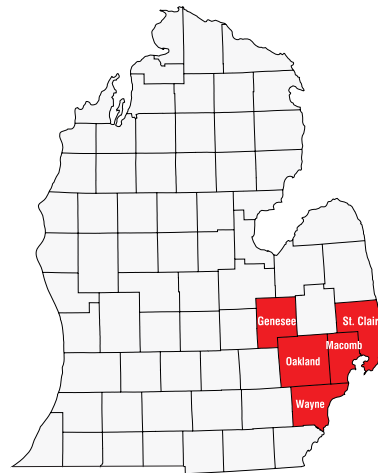

CRIMINAL BACKGROUND ON ALL EMPLOYEES



Prior to Application

- ◆ Must have 1 year current experience in the medical field
- ◆ Multiple levels of interviews
- ◆ Written and Clinical Competency Evaluations

After Application & Prior to Orientation

- ◆ Required criminal back ground check prior to orientation
- ◆ License / Registry Verification
- ◆ Current TB and Physical
- ◆ Reference Checks
- ◆ Certified in CPR and Standard First Aid

Orientation

- ◆ Mandatory 2 days of orientation
- ◆ Specialized training and competency evaluation in specific areas of training

Yearly Requirements

- ◆ 12 hours of continued education units
- ◆ In-services
- ◆ CPR / First Aide Certification
